Entry Visa

Flight

Airport Transfer

Taxis from the Changi International Airport to the hotel will cost approximately S\$30 and takes about 20-30 minutes.

Taxis are the most convenient way to get around Singapore. Note: New Rules as of 1 March 2008, taxis are not allowed to pick up/drop any passenger by the roadside within CBD area. Please wait at the nearest taxi stand/hotel lobby instead.

Weather

The weather is usually sunny with no distinct seasons. Rain falls occasionally, usually in sudden, heavy showers that rarely last longer than an hour, so it is wise to carry an umbrella at all times, both as a shade from the sun or cover from the rain.

10% service charge is usually included in the bill. In such cases tipping is not necessary. Tipping of taxi drivers is not customary.

Food & Drink

Water from the tap is safe for drinking. Otherwise you can buy bottled mineral water from convenience stores such as 7-eleven or supermarkets.

Gluttons Bay – Non air-conditioned hawker centre that serves good seafood and other variety. Try the sambal stingray, sambal sotong or chilli crabs if you would like some spicy taste.

Lau Pa Sat – You can find a whole row of stalls selling chicken, mutton, beef, prawn satay etc from 7pm daily. There are also stalls that sell local food such as laksa, bakt ku teh, hainanese chicken rice & roti prata etc.

The SkyBar is the perfect hangout from which to survey the world below, Take in the vista of the city spread out before you and the panoramic view of the Singapore Strait as you sip on cocktail creations by KU DÉ TA mixologists.

Shopping

There are several areas in Singapore that are good for shopping:-

Orchard Road – You will find a whole stretch of shopping centers such as Wisma Atria,

Takashimaya, Paragon and Centrepoint etc. The newest addition will be ION, Orchard Central and 313@Somerset.

Festive Walk – Resorts World Sentosa showcases Asia's first Chihuly Gallery, the world's first Michael Graves Gallery[™] and numerous other luxury retail outlets, making it a treasure trove of exclusive and tempting finds.
